## GQA LEVEL 2 NVQ DIPLOMA IN AUTOMOTIVE GLAZING

### Who is this qualification for?

This qualification is aimed at those who work in the replacement automotive glazing industry. The standards cover the most important aspects of the job. This qualification is at Level 2, although there may be individual units at other levels, and should be taken by those who are fully trained to deal with routine assignments. Candidates should require minimum supervision in undertaking the job.

Candidates for this qualification will primarily be:

- Working in a Fitting Centre or on site
- Working with standard production vehicles (i.e. those produced by mass market manufacturers)
- Removing, replacing and repairing glass and other standard automotive glazing components

Candidates could have jobs entitled:

- Automotive Glazing Technician
- Automotive Glazier
- Windscreen Fitter

Other Automotive Glazing qualifications are available from GQA.

### What is required from candidates?

GQA qualifications are made up of a number of units that have a credit value or credits. These credits must be achieved in the correct combination from mandatory and optional units. Candidates should achieve all of the mandatory units listed below, which total 34 credits plus a minimum of 3 credits from the group of optional units. This makes the minimum credit value of the qualification 37 credits.

The units are made up of the things you need to know and the things you need to be able to do to carry out your job safely and correctly. These are called Learning Outcomes, and all must be met to achieve the unit.

### Assessment Guidance:

Evidence should show that you can complete all of the learning outcomes for each unit being taken.

### Types of evidence:

Evidence of performance and knowledge is required. Evidence of performance should be demonstrated by activities and outcomes, and should be generated in the workplace only, unless indicated under potential sources of evidence (see below). Evidence of knowledge can be demonstrated through performance or by responding to questions.

### Quantity of evidence:

Evidence should show that you can meet the requirements of the units in a way that demonstrates that the standards can be achieved consistently over an appropriate period of time.

### Potential sources of evidence:

The main source of evidence for each unit will be observation of the candidate's performance and knowledge demonstrated during the completion of the unit. This can be supplemented by the following types of physical or documentary evidence:

- Accident book/reporting systems
- Safety records
- Training records
- Audio records
- Job specifications and documentation
- Delivery Records
- Witness testimonies
- Correspondence with customers
- Notes and memos
- Photo/video evidence
- Work diaries
- Timesheets
- Telephone Logs
- Meeting records
- Records of toolbox talks
- Equipment
- Prepared materials and sites
- Completed work
